OVERVIEW

The on-farm Dairy Welfare Auditor Course conducted by the Professional Animal Auditor Certification Organization (PAACO) is the certification course to train potential dairy farm auditors using the Dairy Well Audit tool. PAACO is an organization of eight professional animal organizations with extensive expertise on best management practices and current science in animal agriculture.

EDUCATION & EXPERIENCE

(Note the following are not a requirement to take the course, but are required for certification.)

- Master's, Ph.D., DVM with relevant livestock experience of 2 years within the past 5 years
- Associate or Bachelor's degree with relevant livestock experience of 3 years within the past 7 years
- High school diploma with relevant livestock experience of 5 years within the past 10 years.

AUDITOR CERTIFICATION PROCESS

#1

Complete online training focused on familiarization with the audit tool.

#2

Participate in a 3-day education/instruction course including on-farm experience and pass the written exam.

#3

Conduct and complete no less than two dairy farm audits under the supervision of a PAACO dairy certified auditor of your choice.

#4

Upon the completion of satisfactory ratings in Step 3, an official endorsement as a PAACO "Certified Dairy Welfare Auditor" will be issued and your information included in a data base of certified auditors.

PARTICIPANT & AUDITOR QUALIFICATIONS

Class size WILL be limited, and spaces allocated with priority given to those currently performing audits.

Additionally, individuals must meet the following qualifications:

Basic individual requirements and qualifications to attend the course and be certified are:

- Read, write and walk unassisted in a dairy production environment
- Trainees must not have traveled outside the US within two weeks of April 9, 2019. If this is an issue, please contact PAACO as we may ask that they take extra precautions.
- Any clothes or shoes worn on the farm should be washed and boots disinfected before being worn on any farm
- Trainees who have traveled to known geographies where FMD (Foot and Mouth Disease) actively exist should let PAACO know, as we may ask that they take extra precautions.

COURSE MATERIALS

PAACO trainings typically use one audit instrument for training. This training is designed to instruct auditors on the use of the Dairy Well audit tool, and it will be cross referenced with relevant industry material, including the FARM Program. Each attendee should familiarize themselves with the audit instrument and guidelines prior to attending the training. Copies of the audit tool and guidelines will be provided.

All attendees must complete an online course to be prepared. This course will be a series of repeatability tests and some homework to print out and bring with to the onsite training. Registrants will be sent information regarding this prior to the course. Cost of this course is included in your registration fee.

PREREQUISITE: ONLINE TRAINING

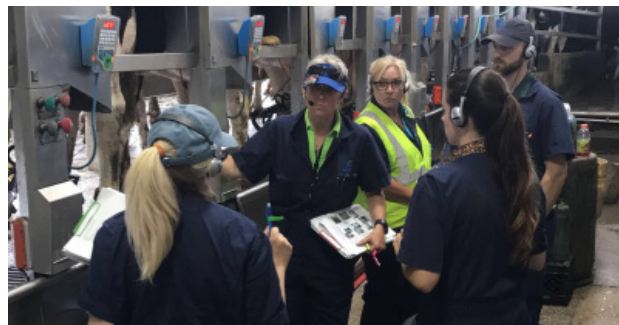
